Upon your arrival, proceed directly into the main office building. You will be provided with safety gear, which includes vests, glasses, and hard hats. These items must be worn at all times outside of the main office building.

Our sorting equipment and machinery is well-guarded and all tours are supervised. However, we do require that tour participants 18 years of age or younger have a signed copy of this Form.

As a parent or guardian of a tour participant, it is important that you recognize that there is a potential risk of physical injury to the participant. By signing this form you agree to assume the full risk of injuries or damages (including but not limited to damage to property) or loss which may be sustained while visiting the Homewood Disposal facility, or in activities associated with such facility. Furthermore, as a parent or guardian of a participant, you agree to indemnify and hold harmless, and defend "Homewood", from any and all claims resulting from injuries, damages, and/or losses sustained by visitor/ participant, or me individually, arising out of or in any way associated with the visit to "Homewood".
